




Figure 1-3 Overview




Figure 1-5 Type III Overview

Note:

The indicator varies according to different device models.

Press RESET about 10 s when the camera is power on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.



- Only certain models support WPS function.
- A wireless router with the WPS function is required to enable the WPS function of the camera. Refer the steps below.

Steps:

- 1. Press the WPS button on the router.
- Press the WPS button (about 2 s) on the camera within 120 s you enable the WPS of the router to join in the wireless network.

Note:


- The WPS button works as a reset button only when you
 press it when the camera is powering on.
- Press the WPS button on the camera, and then press the WPS button on the router will work as well, and the expire time of WPS connection on the camera is 120 s.
- The link indicator blinks if the wireless connection succeeded.

2 Notice

 Do not install the camera in the extreme whether condition.



 Do not install the camera towards the strong light or in the unstable lightening condition.





 Do not subject the camera to vibration, shock or heavy pressure.





- High humidity may damage the camera hardware; put it in dry and well-ventilated place.
- Under no circumstances should you submerge the camera in any type of liquid.





 Electromagnetic radiation may affect the video data transmission and the image quality. Do not install the camera near electromagnetic radiation source.



3 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

3.1 Memory Card Installation

This series of camera supports memory card installation. Follow the steps below to install the memory card.

3.1.1 Type I, II

Steps:

- 1. Insert the memory card into the card slot on the side of the camera.
- 2. (Optional) Push the inserted memory card to get it sprung out.




Figure 3-1 Install Memory Card

3.1.2 Type III

Steps:

- 1. Remove the memory card slot cover.
- 2. Insert the memory card into the slot.
- 3. (Optional) Push the inserted memory card to get it sprung out.
- 4. Replace the slot cover.




Figure 3-2 Install Memory Card

3.2 Type I, II Camera Mounting

3.2.1 Stand Mounting

Steps:

1. Take the bracket out from the package.

 Align the camera body to the bracket, and rotate the camera body to fix it with the bracket.




Figure 3-4 Install the Camera Body

3. Assemble the camera as the steps above, and put the camera on the flat surface.

3.2.2 Ceiling Mounting

Steps:

1. Drill the screw holes according to the drill template.

 Disassemble the 3-axis bracket. Hold the base with one hand, and rotate the pole anticlockwise to disassemble the pole from the base.




Figure 3-6 Disassemble the Bracket

- 3. Install the fixed tray to the ceiling with the supplied screws.
- 4. Install the base to the fixed plate.

5. Install the camera to the bracket.

- 6. Adjust surveillance angel
 - Loosen the knob to adjust the panning position and tilting position.
 - After adjusting the angle of the camera to the desired position, fasten the knob.




Figure 3-9 Adjust the Camera

3.3 Type III Camera Mounting

This type of camera supports ceiling mounting and wall mounting. The following describes the steps for the wall or ceiling mounting.

Steps:

 Install the adapter plate to the wall or ceiling with the supplied screws.




Figure 3-10 Install the Adapter Plate

2. Buckle the camera base into the adapter plate.

Note:

You are recommended to push into two buckles 1 and 2 first and then the third buckle 3. Then the camera can be fastened firmly on the base.




Figure 3-11 Buckle the Camera into Adapter Plate

- 3. Adjust surveillance angel.
 - Loosen the adjusting knob 1 to adjust the panning position and tilting position.
 - 2). Loosen the adjusting knob 2 to adjust the rotation position.
 - After adjusting the angle of the camera to the desired position, fasten the two knobs.




Figure 3-12 Adjust the Camera

4 Setting the Network Camera over the LAN

4.1 Wiring

Connect the camera to network according to the following figures.




Figure 4-2 Connecting via a Switch or a Router

4.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for Activation via Client Software.

4.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- 2. Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

- 5. Click OK to save the password and enter the live view interface.

4.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

Steps:

- 1. Run the SADP software to search the online devices.
- 2. Check the device status from the device list, and select the inactive device.

Note:

The SADP software supports activating the camera in batch. Refer to the user manual of SADP software for details.

Create and input the new password in the password field, and confirm the password.



STRONG PASSWORD RECOMMENDED- We highly

recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

Note:

You can enable the Guarding Vision service for the device during activation. Refer to Chapter 6.1 for detailed information.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

4.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an activate device.

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

6 Operating via Guarding Vision App

Purpose:

Guarding Vision is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Guarding Vision service is not supported by certain camera models.

6.1 Enable Guarding Vision Service on Camera

Purpose:

Guarding Vision service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

6.1.1 Enable Guarding Vision Service via SADP Software

Steps:

- 1. Check the checkbox of Enable Guarding Vision on:
 - 1). "Activate the Device" page during camera activation, refer to Chapter 4.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 4.3.
- 2. Create a verification code or change the verification code.

6.3 Adding Camera to Guarding Vision

Before you start:

You need to enable the Guarding Vision service on camera before adding it to your Guarding Vision account. Refer to Chapter 6.1.

Steps:

1. Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

After the camera connects to the network, please wait one minute before any operation on the camera using Guarding Vision app.

2. In the Guarding Vision app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera.

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the discontant inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Guarding Vision service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- 4. Follow the prompts to set the network connection and add the camera to your Guarding Vision account.

Note:

For detailed information, refer to the user manual of the Guarding Vision app.

6.4 Initializing the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
